Must a private investigator be licensed to perform investigations?

- Most states require a private investigative company to be licensed.
- In Texas, investigative companies are licensed by the Texas Department of Public Safety Private Security Bureau.
- A public database that allows anyone to search for whether or not an investigative company or individual is legally licensed/registered as a private investigator or investigative company.

What is the purpose of a background check?

- Verify previous employment, education, and qualification claims.
- Verify employee integrity
- Verify reliability
